This group realized it was time to develop a long-term plan, keeping in mind the primary desire being to glorify God and strengthen our parish community. The Strategic Planning Committee ("SPC") was established with its mission to provide advice to the Parish Finance Council and pastor. The SPC is designed to represent the diverse interests of the parish as to future capital needs, capital development, land use, and related forward looking needs in conjunction with the Diocese of Charlotte.

The SPC members include parish employees, parishioners, and our pastor. Parish Director of Operations, Michael Becker, serves as the staff administrator for the SPC. The SPC duties and responsibilities include:

- <u>Gathering and Analyzing Information</u>: The SPC seeks input and feedback from interested parties within the parish to develop the strategic plan. Interested parties generally include all registered parishioners, registered families of the school, parish organizations, and the Diocese of Charlotte.
- <u>Determining Key Priorities and Goals</u>: The SPC will collect, analyze, and prioritize all information received from all parties. All responses will be considered and the SPC will develop a prioritized list of needs and timing of identified strategic planning items to the finance council and pastor for feedback and approval.
- Establishing a Strategic Plan: The SPC will develop a detailed 5-year strategic plan and a record of other potential projects to consider beyond the 5-year plan.

The SPC is not a "one and done" committee. Following the creation of the initial strategic plan, priorities of parish needs will be re-evaluated at least annually by the SPC. This may result in revising the Parish Strategic Plans to reflect the change in parish needs and available resources.

We have been blessed with the time, talent, and treasure of the Sacred Heart Parish Community and are excited to begin this new journey following a faithfully developed plan.

Dear Sacred Heart Family,

On the eve of our final debt payment, your Parish Finance Council is humbled by your dutiful financial commitment to our parish. No matter the size of investment, we are confident that all are giving according to their means, and we say "Thank you!" as it bears out in our financial results.

As you will read in more detail elsewhere in this annual report, the finance council has established a Strategic Planning Committee to consider current and future capital needs that have either been deferred or identified. Your prayerful and thoughtful responses to the parish survey will serve as a guide map for our land use and capital needs well into the future. Immediately identified through our committee process is the construction of an on-campus rectory, which is in the planning stages now.

The school also continues to perform above plan, with currently 195 students, resulting in excellent financial results. In addition, with the recent passage of the expanded NC Opportunity Scholarship Program, we will be able to enhance our ability in removing financial barriers for all students that desire a high-quality Catholic education. Also, the school and church administration and volunteer teams have made significant investments in time and treasure to enhance our safety procedures and physical facility for the protection of all.

The Parish Finance Council team believes the parish is well positioned for another excellent year with our key focus being transparency and conservative financial management. We thank you for your continued trust, support, and prayers.

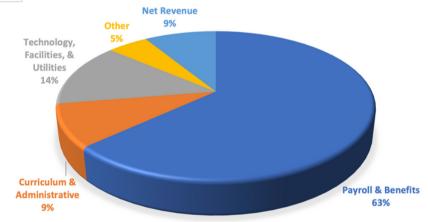
